Final Report of the Inspector of Elections

I, the undersigned, duly appointed Inspector of Elections at the Annual Meeting of Shareholders (the "Meeting") of Starbucks Corporation (the "Company") held on March 21, 2012, hereby certify that:

- 1) Before entering upon the discharge of my duties as Inspector of Elections at the Meeting, I took and signed an Oath of Inspector of Elections.
- 2) The Meeting was held at 321 Mercer Street in Seattle, Washington pursuant to notice duly given.
- 3) At the close of business on January 12, 2012, the record date for the determination of shareholders entitled to vote at the Meeting, there were 749,718,625 shares of the Company's common stock outstanding, each share being entitled to vote.
- 4) At the Meeting, the holders of 670,027,408 shares of the Company's common stock were represented in person or by proxy.
- 5) The undersigned received the votes of the shareholders from Broadridge Financial Solutions, Inc., or from one of its affiliates, and by ballot at the Meeting, on the matters presented at the Meeting.
