For the purpose of environmental protection and cost saving, we encourage you to select the Website Version. Even if you have chosen the Website Version, you reserve the right at any time by giving reasonable notice in writing to the share registrar of the Company (“Share Registrar”) to change your choice.

Please mark a (X) in the appropriate box in the enclosed Reply Form and sign and return the same with the mailing label provided to the Share Registrar, Computershare Hong Kong Investor Services Limited, Rooms 1806-1807, 18th Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong or by fax at (852) 2117 1656.

If we do not receive the Reply Form from you by 9 October 2009 and until you inform the Share Registrar otherwise by reasonable notice in writing, only a printed Chinese version of the Corporate Communications will be sent to you if you are a shareholder who is a natural person with a Chinese name and has an address in Hong Kong appearing on the register of members of the Company. Otherwise, we will only send you a printed English version of the Corporate Communications.

Please note that: (i) both the printed English and Chinese versions of the Corporate Communications will be available from the Company or the Share Registrar on request; and (ii) both the English and Chinese versions of the Corporate Communications will be available on the Company’s website at [www.fosun-international.com](http://www.fosun-international.com) and on the website of The Stock Exchange of Hong Kong Limited at [www.hkexnews.hk](http://www.hkexnews.hk).
