<b>Optional Redemption:</b>	The Issuer may, at its option, redeem the shares of Preferred Stock (i) in whole but not in part at any time prior to June 15, 2018, within 90 days after the occurrence of a "rating agency event" at a redemption price equal to \$25,000 per share, or if greater, the present values of (A) \$25,000 per share of Preferred Stock and (B) all undeclared dividends for the dividend periods from the date of redemption to and including June 15, 2018, in each case, discounted to the date of redemption on a quarterly basis at a discount rate equal to the treasury rate plus 35 basis points, plus, in each case, any declared and unpaid dividends, without regard to any undeclared dividends, to but excluding the redemption date, or (ii) in whole or in part, from time to time, on any dividend payment date on or after June 15, 2018 at a redemption price equal to \$25,000 per share, plus any declared and unpaid dividends, without regard to any undeclared dividends, to but excluding the redemption date.
<b>Listing:</b>	Application will be made to list the Depository Shares on the New York Stock Exchange (the "NYSE") under the symbol "ALL PR A". If approved for listing, trading of the Depository Shares on the NYSE is expected to commence within a 30-day period after the original issuance date of the Depository Shares.
