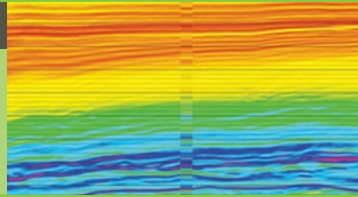

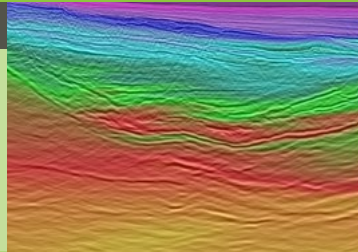
Seismic Data Library

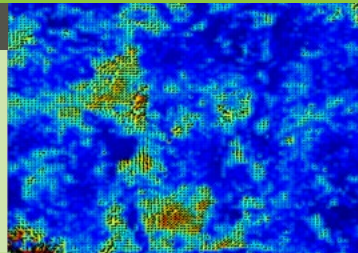
Imaging Services

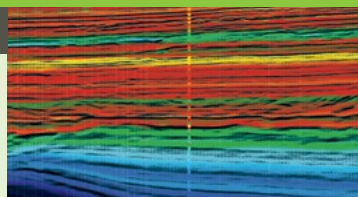
Optimization Software and Services
