Explanation of Responses														

- (1) A restricted stock award of 12,000 shares was made on March 22, 2012 and 3,000 shares become vested on each March 22 of 2013, 2014, 2015 and 2016.
- (2) A restricted stock award of 15,000 shares was made on March 1, 2013, and 3,750 shares became vested on each March 1, 2014, 2015, 2016 and 2017, in each case dependent on the achievement of certain performance goals.
- (3) 1,410 shares were withheld (not sold) on February 27, 2015 to pay income tax obligations upon vesting of restricted stock.
- (4) The options with respect to the shares of common stock are currently exercisable.
