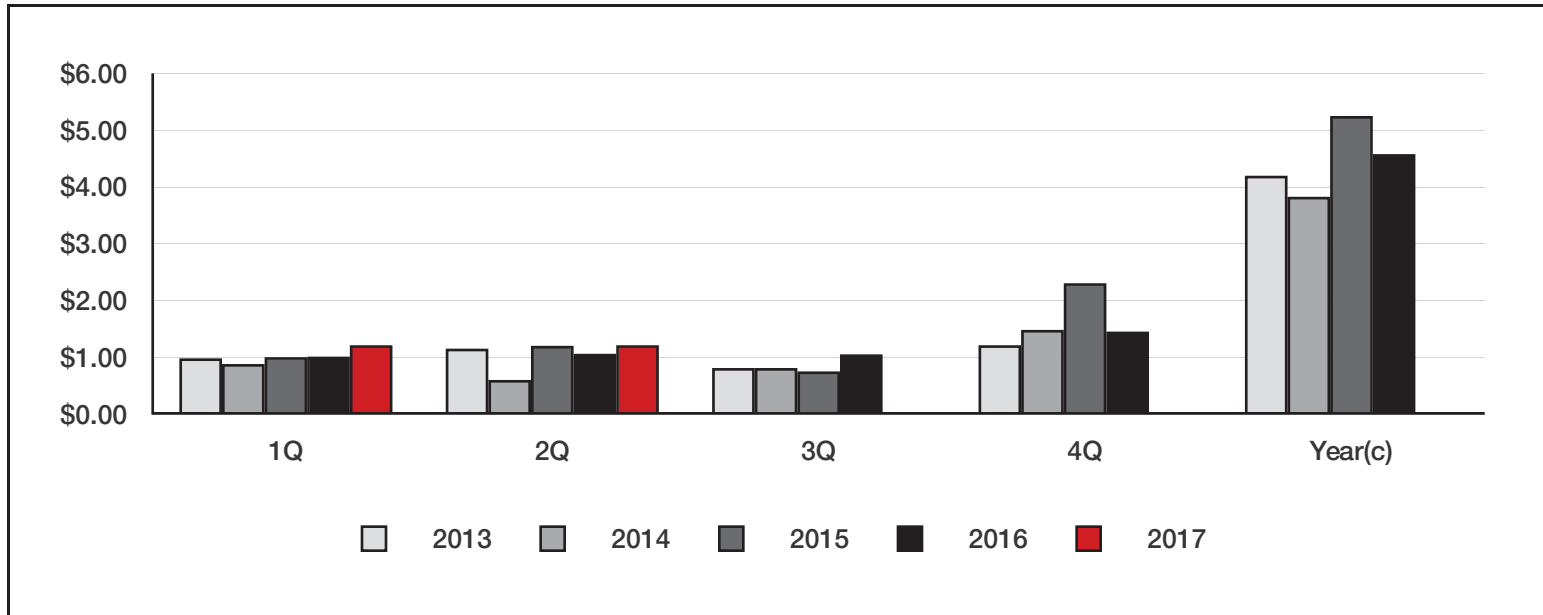


GAAP diluted earnings per share from continuing operations ^{(a) (b)}
