OUTLOOK STATEMENT FOR 2018

Earnings Outlook

- Full-year 2018 adjusted earnings of \$5.20 to \$5.60 per diluted share.
- First quarter adjusted earnings of \$1.45 to \$1.59 per diluted share.

Agricultural Solutions

- Full-year 2018 segment revenue of approximately \$3.95 to \$4.15 billion.
- Full-year segment EBITDA of \$1.05 to \$1.15 billion.
- First quarter segment EBITDA of \$290 to \$320 million.

Lithium

- Full-year 2018 segment revenue of approximately \$420 to \$460 million.
- Full-year segment EBITDA of \$180 to \$200 million.
- First quarter segment EBITDA of \$44 to \$48 million.
