

IAG - AGM Privacy policy

1. Introduction

This privacy policy explains how we, International Consolidated Airlines Group, S.A. (“**we**”) use personal data collected about attendees and participants at our annual general meeting (“**you**”) (“**AGM**”). It describes:

- what information we collect about you;
- how we use your personal data;
- who we share your personal data with;
- your rights regarding our use of your personal data;
- how long we keep your personal data; and
- how to contact us.

2. What personal data do we collect about you?

Both audio and video recordings will be made of the AGM. Accordingly, while making such recordings, we may collect personal data about you such as your voice, image and name.

3. How do we use your personal data?

We may use your personal data as part of the audio and video recordings of the AGM which we produce. We will process any such personal data in accordance with this policy to pursue our legitimate interests, which include adhering to best practice recommendations for publicly listed companies.

4. Who do we share your personal data with?

Live audio and video transmissions of the AGM will be made available on our website, www.iairgroup.com.

We may also share your personal data with the below categories of third parties:

- certain service providers in order to process and produce the audio and video recordings and put them on our website; and
- local and foreign public authorities but only to the extent required by law, court order, or if necessary to establish, exercise or defend our legal rights, including if we suspect fraud or attempted fraud.

5. What are your rights in relation to our use of your personal data?

You have rights under data protection law in relation to our use of your personal data, including to:

- request access to your information, which you can do by contacting us using the details in Section 7;
- object to certain uses of your personal data (which includes processing based on legitimate interests) on grounds relating to your particular situation;
- request the deletion of your personal data, or restrict its use, in certain circumstances; and

- to lodge a complaint with the relevant supervisory authority, which for the UK is the Information Commissioner's Office (www.ico.org.uk).

6. How long do we keep your personal data?

We will retain audio and video recordings of the AGM for our own internal records on an indefinite basis. However, after the live audio and video transmissions of the AGM have concluded the recordings will not be made available on our website (i.e.. there will be no playback option).
