Election of Means and Language of Receipt of Corporate Communications

You may choose:

- (1) to receive a printed English version of the Corporate Communications only; or
- (2) to receive a printed Chinese version of the Corporate Communications only; or
- (3) to receive both the printed English and Chinese versions of the Corporate Communications; or
- (4) to read the Corporate Communications published on the Company’s website (“**Website Version**”) instead of receiving printed copies.

For the purpose of environmental protection and cost saving, we encourage you to select the Website Version. Even if you have chosen the Website Version, you reserve the right at any time by giving reasonable notice in writing to the share registrar of the Company (“**Share Registrar**”) to change your choice.

Please mark a “X” in the appropriate box in the enclosed Reply Form and sign and return the same with the mailing label provided to the Share Registrar, Computershare Hong Kong Investor Services Limited, 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong or by fax at (852) 2117 1656.

If we do not receive the Reply Form from you by 24 May 2010 and until you inform the Share Registrar otherwise by reasonable notice in writing, only a printed Chinese version of the Corporate Communications will be sent to you if you are a shareholder who is a natural person with a Chinese name and has an address in Hong Kong appearing on the register of members of the Company. Otherwise, we will only send you a printed English version of the Corporate Communications.

Please note that: (a) both the printed English and Chinese versions of the Corporate Communications will be available from the Company or the Share Registrar on request; and (b) both the English and Chinese versions of the Corporate Communications will be available on the websites of Company (www.fosun-international.com) and The Stock Exchange of Hong Kong Limited (www.hkexnews.hk).
