There were no shares entitling the holders to attend and vote only against the resolutions at the AGM and there were no restrictions on any shareholder casting votes on the resolutions proposed at the AGM.

3. No party has stated its intention to vote against the resolutions proposed at the AGM or to abstain from voting.
4. Shareholders and authorised proxies holding an aggregate of 6,366,239,400 shares, representing 99.1380% of the issued share capital of the Company, were present at the AGM. The holding of the AGM was in compliance with the requirements of the Companies Ordinance (Chapter 32 of the Laws of Hong Kong) and the memorandum and articles of association of the Company. The AGM was chaired by Mr. Guo Guangchang, the Chairman and an executive director of the Company.
5. Computershare Hong Kong Investor Services Limited, the Company's share registrar, acted as the scrutineer for the vote-taking at the AGM.
