(2) 1,957 shares were withheld (not sold) on March 22, 2016 to pay income tax obligations upon vesting of restricted stock. (3) The options with respect to the shares of common stock are currently exercisable. (4) Restricted stock units (RSUs) are awarded under the Company's 2010 Omnibus Award Plan and 1,250 units vest on April 23, 2016.
