Explanation of Responses

(1) 164,948 shares were withheld (not sold into the market) on July 18, 2016 for the purpose of paying the exercise price of the stock option and income tax obligations and only the remaining 100,000 shares were sold into the market. (2) The price reported is a weighted average price. (4) Restricted stock units are awarded under the Company's 2010 Omnibus Award Plan and vest on June 8, 2017. (5) The options with respect to the shares of common stock are currently exercisable.
