(2) 28,593 shares were withheld (not sold into the market) on June 10, 2019 for the purpose of paying the exercise price of the stock options and income tax obligations. (3) The price reported is a weighted average price. The reporting person undertakes to provide to the issuer, any security holder of the issuer or the staff of the Federal Deposit Insurance Corporation, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in this Form 4. These shares were sold at prices between \$99.26 and \$99.55. (4) The reporting person is a general partner of the partnership that owns the reported securities. The reporting person disclaims beneficial ownership of these securities except to the extent of this pecuniary interest therein, and the conclusion of these shares in this report shall not be deemed an admission of beneficial ownership of all of the reported shares for purposes of Section 16 or any other purposes. (5) The reporting person and spouse serve as the managers of this limited liability company. (6) The options with respect to the shares of common stock are currently exercisable. (7) Restricted Stock Units are awarded under the Company's Omnibus Award Plan with 9,142 units scheduled to vest on January 22, 2020 and 9,141 units scheduled to vest on January 22, 2021 and 2022.
