1. Further to the Immediate Report published by the Company on December 16, 2008 (Reference Number: 2008-01-357021), regarding Volkswagen AG ("VM")'s notice as to the transfer of its shares in Dead Sea Magnesium Ltd. ("DSM") to ICL, we hereby report that on July 1, 2009, a compromise agreement has been signed between ICL group and VW, which the following is its principles:

1. VM will provide DSM with a sum of USD 30M.
2. All VW's shares in DSM will be transferred to the ownership of ICL, without consideration.
3. All parties waive their claims against each other.

Simultaneously with the injection of VW, as aforementioned, ICL will provide DSM with a sum of USD 55.71M.
