With an enterprise value of around \$6 billion, NuStar Energy L.P. (NYSE: NS) is a master limited partnership based in San Antonio, TX. NuStar currently has 8,700 miles of pipeline and 79 terminal and storage facilities that store and distribute crude oil, refined products and specialty liquids. The partnership's combined system has approximately 93 million barrels of storage capacity at its facilities around the world, and NuStar has operations in the United States, Canada, Mexico, the Netherlands, including St. Eustatius in the Caribbean, and the United Kingdom.
