As of December 31, 2017, we had total assets of Ch\$35,804,279 million (U.S.\$58.0 billion), outstanding loans net of allowances for loan losses of Ch\$26,747,542million (U.S.\$43.4 billion), total deposits of Ch\$19,682,111 million (U.S.\$ 31.9 billion) and equity of Ch\$3,108,086million (U.S.\$5.0 billion). Our headquarters are located in Santiago and we operate in every major region of Chile. Our long-term credit risk rating are Aa3 by Moody's, A Fitch and A Standard & Poor's.
