

Tania Ortiz Mena appointed CEO of IEnova. Carlos Ruiz Sacristán appointed Chairman and CEO of Sempra North American Infrastructure and Executive Chairman of the Board of Directors of IEnova

In his new role, Ruiz Sacristán will lead the group of Sempra’s North America infrastructure affiliates, which includes IEnova and Sempra LNG & Midstream; the later will have oversight of the LNG project of Energía Costa Azul in Ensenada, Baja California; the LNG terminal of Cameron in Louisiana; and the LNG terminal in Port Arthur, Texas, among others.

During the last 6 years in which Carlos Ruiz Sacristán led IEnova, the company became the first private energy company to be listed in the Mexican Stock Exchange and
